## Information according to REACH (regulation 1907/2006) and SVHC

Dear Sir or Madam,

at KGM Kugelfabrik GmbH & Co.KG, we are aware of our responsibility towards customers, suppliers and the environmental at all times. Thus we would like to inform you about our status concerning REACH.

As a ball-manufacturer, pursuant to REACH, we use solely products as primary material. Thus we view ourselves as a downstream user. A processing or alteration of chemical substances does not occur. Furthermore according to present knowledge our products do not release any substances, either intentionally or unintentionally. Therefore KGM Kugelfabrik GmbH & Co.KG is consequently exempt from a registration or pre-registration.

We know the obligation of information according to the article 33 section 1 of REACH, which is valid for the complete supply chain. This obligation means, that a supplier has to inform its customer, when a product contains a SVHC-substance with concentration of more than 0,1 % of its total mass.

Until now, KGM did not get information about SVHC by sub-suppliers (excluded are parts with nickel coating – but the percentage of lead of weight is < 0,1%).
